Submitting an application to the Lakefield Farmers' Market does not guarantee a place in the market. The management team reserves the right to choose vendors who fit most closely with the vision of the market, which is to provide high quality, locally-produced food and artisanal wares to our customers.

Established or returning vendors with proven good attendance have first right of refusal of their previous stalls. New vendors will be assigned a stall based on availability and the best interests of both the Lakefield Farmers' Market and the vendor. Eligible new vendors will be selected on a first-come, first-served basis until market stalls are full.

Once signed, this document is considered binding for all vendors who accept their invitation to sell at the Lakefield Farmers' Market. Barring exceptional circumstances, the Lakefield Farmers' Market runs rain or shine, for 21 weeks from May to October (specific dates vary year-to-year). It is expected that all vendors will honour their agreed-upon time commitment to the market, whether full season, pro-rata, or daily.

Application Fees are due upon application. At least 50% of Membership Fees, Attendance Fees and Stall Fees is due at the time of acceptance into the market. The Stall Fee, Membership Fee and Application Fee are non-refundable. The Attendance Fee is refundable at the end of the Market season provided vendors have had fewer than 2 unannounced absences (non-refundable to those with 2 or more unannounced absences). If your first payment is not received in a reasonable timeframe after the acceptance of your application, the Lakefield Farmers' Market reserves the right to reassign your stall. The remainder of your stall fees are due on or before your first scheduled market day. Receipts will be issued only at your request.

Vendor Declaration:

- I declare that the information provided above is true and accurate, and that I have read the Lakefield Farmers' Market Vendors' Handbook and agree to abide by its rules and regulations.
- I understand that the Lakefield Farmers' Market is meant to be a market for local producer-vendors, and that re-sellers are not eligible for membership.
